<b>Summary</b>	In vivo mutagenicity in rats occurs by mechanisms secondary to a threshold effect and is a consequence of "lung overload," which leads to chronic inflammation and the release of genotoxic oxygen species. This mechanism is considered to be a secondary genotoxic effect and, thus, carbon black itself would not be considered to be mutagenic.
<b>Genotoxicity - in vitro</b>	Carbon black is not suitable to be tested directly in bacterial (Ames test) and other in vitro systems because of its insolubility. However, when organic solvent extracts of carbon black have been tested, results showed no mutagenic effects. Organic solvent extracts of carbon black can contain traces of polycyclic aromatic hydrocarbons (PAHs). A study to examine the bioavailability of these PAHs showed that they are very tightly bound to carbon black and are not bioavailable (Borm, 2005).
<b>Genotoxicity - in vivo</b>	In an experimental investigation, mutational changes in the hprt gene were reported in alveolar epithelial cells in the rat following inhalation exposure to carbon black (Driscoll, 1997). This observation is considered to be rat-specific and a consequence of "lung overload," which leads to chronic inflammation and release of reactive oxygen species. This is considered to be a secondary genotoxic effect and, thus, carbon black itself would not be considered to be mutagenic.
